RESOLUTION NUMBER R- 263684

ADOPTED ON JUL 15 1985

WHEREAS, a famine exists in Ethiopia that has caused human suffering, loss of life and devastation that transcends human comprehension; and

WHEREAS, the starving people are in desperate need of nutrition and medical services; and

WHEREAS, "Operation California: Mission San Diego" is an effort to assist those famine victims across the globe by raising funds and airlifting medical supplies; and

WHEREAS, "Operation California: Mission San Diego" includes many dedicated and selfless individuals who have given of their time and energy, including: local hospitals that generously and quickly responded to requests for medical supplies, and the San Diego Padres and the students of the San Diego Unified School District who have participated in the "Students for Life" campaign to sell 10,000 tickets donated by the Padres to their July 21 game against the Pittsburgh Pirates; and

WHEREAS, the Mission San Diego has a goal of raising \$100,000 with the culmination of fundraising efforts on July 21, 1985 on which day a Walk for Hunger will be held, the San Diego Padre game will be played, and an afternoon cruise on the Invader, and a jazz concert will be conducted; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council commends all those participants of Mission San Diego

for their humanitarian concern and efforts, and urges all San Diegans to join in this effort so that precious lives can be saved in this drought stricken part of the world.
