RESOLUTION NUMBER R- 263685

ADOPTED ON JUL 15 1985

WHEREAS, The City of San Diego experienced a devastating fire in Normal Heights on June 30, 1985; and

WHEREAS, this fire was the worst in the City's history; and

WHEREAS, the following organizations are volunteering their services to hold a special event at San Diego Jack Murphy Stadium to raise funds to be donated to the fire victims: San Diego Fire Fighters, San Diego Police Department, Channel 8, Channel 10, San Diego Padres, San Diego Chargers, Pacific Bell, Great American, Union Tribune, Coast Distributors, Coca Cola, San Diego Symphony, and others; and

WHEREAS, these groups have determined to waive any fees from such an event that would be realized by their organizations; and

WHEREAS, these groups have requested the City's participation and good faith effort in waiving the ten percent (10%) of gross ticket sales, and the parking fees (\$2.00 per car); NOW,
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and directed to issue a Special Use Permit and waiving the ten percent (10%) of gross ticket sales rent and parking fees to a consortium of organizations who are volunteering and joining together to hold a special event at San Diego Jack Murphy Stadium on or about July 29, 1985 to raise money to assist the victims of Normal Heights

Fire; provided assurances can be given which are satisfactory to the City Manager and City Attorney that the proceeds of the event will be duly set aside for the charitable purposes set forth above.
