BE IT FURTHER RESOLVED, that the expenditure of \$120,000 from Trust Fund 63021 to supplement \$519,700 previously authorized by Resolution No. R-260626, adopted on May 7, 1984, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and

Comptroller upon advice from the administering department to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to review and, if appropriate, negotiate with the Boy's Club of San Diego, Inc. a further amendment to that Agreement previously authorized by Resolution No. R-260626 adopted on May 7, 1984, for Council approval, to expressly provide for the financial participation by the Boy's Club of San Diego, Inc. in the overall renovation of the Boy's Club of San Diego, Encanto Facility, Phases II and III, and to report back to the Public Facilities and Recreation Committee within 90 days the results thereof.
