
BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$20,000 from PSD Fund 13430 to CIP No. 29-526 GERSHWIN NEIGHBORHOOD PARK - DRAINAGE IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$45,000 from CIP No. 29-526 GERSHWIN NEIGHBORHOOD PARK - DRAINAGE IMPROVEMENTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
