
ADOPTED ON JUL 22 1985

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$14,663 from Capital Outlay Fund 245--Annual Allocation, New Development, CIP 58-001, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
