APPROVING MAP OF SKYLINE PARK

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Thomas F. Devening, a registered civil engineer, entitled "SKYLINE PARK, being a subdivision of a portion of Lot 20 of Encanto, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 749, filed in the office of the County Recorder of San Diego County, May 6, 1893, together with Woodman Street and a portion of Skyline Drive as dedicated to public use, together with a portion of the south half of Detroit Avenue (formerly Denver Avenue) as closed and vacated to public use, excepting therefrom one-half of all oil, petroleum and mineral rights, as contained in deed from Guy L. Nations, a single man, recorded in Book 1294, page 355 of deeds," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: portions of Leghorn Avenue and Skyline Drive, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of general utility facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said portions of public streets are accepted on behalf of the public as heretofore stated and that the easements with the right of ingress and egress for the construction and maintenance of general utilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
