<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Ronald Williams	Fire	\$ 65.00	Mr. Williams is a Captain. One year ago he earned a partial award of \$80.00 for his suggestion to utilize two-wheel blocks on all City vehicles that require wheel blocks. One years experience in the Fire Department has shown a savings of \$487.65. This is the remainder of his award.
John Kellogg	General Services	\$ 45.00	Mr. Kellogg is an Equipment Mechanic. He suggested the replacement of the Twenty-amp fuses and fuse holders on the 5700 series packer with a twenty-amp circuit breaker. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Michael Ansel	General Services	\$ 25.00	Mr. Ansel is a Stock Clerk in the Equipment Division. He suggested the substitution of Glowbrite taillight assemblies for IHC assemblies. The Grote assembly was selected because of the shock mounting. Although savings are difficult to identify, this was considered to be a significant operational improvement.
