ADOPTED ON JUL 23 1985

WHEREAS, the Council of The City of San Diego (the "Council") adopted Resolution No. R-257526 on November 23, 1982, whereby said Council attempted to transfer all of its right and interest in real property located within the Gateway Center East development of the Mount Hope Redevelopment Project; and


WHEREAS, the legal description which was employed to convey said real property failed to transfer all of the real property which the Council intended to convey; and

WHEREAS, a new legal description and Quit Claim Deed have been prepared by which the Council may properly transfer the real property which it intended to convey; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and City Clerk are hereby authorized to execute a Quit Claim Deed conveying property within the Mount Hope Redevelopment Project comprising approximately 50 acres as more particularly described in that deed on file in the office of the City Clerk as Document No. RR- 263735 to the Redevelopment Agency of The City of San Diego.

BE IT FURTHER RESOLVED, that the second and third paragraphs of Resolution No. R-257526, which are correctly stated and not directly related to the transfer, shall remain in force and in effect as they were originally adopted on November 23, 1982 by the Council.
