RESOLUTION NUMBER R- 263763

ADOPTED ON JUL 29 1985

WHEREAS, San Diego Municipal Code section 75.0112 provides for the issuance of paratransit driver identification cards and regulates the operation of paratransit vehicles by such operators, and

WHEREAS, the time required to conduct a full background investigation before issuance of a regular identification card may exceed 60 days, and

WHEREAS, such delay may inhibit the efficient operation of a paratransit system within the City of San Diego, thus justifying the adoption of an interim procedure to expedite the driver identification card issuance process, and

WHEREAS, the Council finds that such an interim procedure can be adopted in the public interest, without jeopardizing public safety, pending adoption of appropriate revisions to the San Diego Municipal Code, NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to issue temporary paratransit driver identification cards pending the approval or denial of an application for a regular paratransit driver identification card under the following terms and conditions:

1. That no temporary identification card may be issued to an applicant prior to satisfactory completion of a local law enforcement agency record check;

2. That any temporary identification card so issued shall be valid only for a period that does not exceed 90 days or until the date of approval or denial of the application for a regular paratransit driver identification card, whichever shall occur first;


3. That a fee of \$2.00 per card be imposed to defray costs involved in the processing of temporary identification cards; and

4. That the issuance of a temporary identification card shall not authorize the applicant to operate a paratransit vehicle after the application has been denied and while pending resolution of any appeal provided for by San Diego Municipal Code section 75.0116.

BE IT FURTHER RESOLVED, that the procedure and authorization hereby established shall terminate upon the effective date of an ordinance incorporating the above or related provisions.
