1. The Council hereby consents to a joint public hearing with the Agency on the proposed Second Amendment to the Redevelopment Plan for the Project and hereby authorizes the City Clerk, in cooperation with the Executive Director of the Agency

(or his designee), to establish the date, time and place therefor.

2. The City Clerk of The City of San Diego shall, in cooperation with the Executive Director of the Agency (or his designee), publish and mail notice of public hearing on the proposed Second Amendment to the Redevelopment Plan, in the manner, and with other documents as required and established by law.
