
RESOLUTION NUMBER R- 263769 ADOPTED ON JUL 2 9 1985

BE IT FURTHER RESOLVED, that the City Attorney be and he is hereby directed to memorialize in appropriate memorandum form the aforesaid terms and conditions.

ATTACHMENT "A"

TERMS AND CONDITIONS

a. Compensation

\$7,922 monthly

b. Deferred Compensation:

\$7,280 per annum to be paid by City to the ICMA Deferred Compensation Plan at the rate of \$280 per pay period.

c. Travel Costs:

City shall pay reasonable one-way air travel costs between Cincinnati and San Diego upon Mr. Murray's final move in September and all reasonable travel costs for two (2) persons as interim (round-trip) travel in August 1985 for a maximum of three (3) days.

d. Housing Assistance:

City shall be obliged to assist Mr. Murray in obtaining housing by offering financial assistance in a sum not to exceed \$25,000 payable in such a fashion as may be mutually agreed upon between Mr. Murray and the City Attorney in order to mitigate federal or state tax consequences.

e. Temporary Rental Expenses:

Payment of a maximum of \$1,000 per month, in arrears, not to exceed three (3) months to accommodate temporary rental costs.

f. Moving Expenses:

City shall pay, as a reimbursable item, reasonable moving expenses for all household items and personal goods from Cincinnati to San Diego. Partial advance payments may be authorized.

g. Severance Pay:

City shall pay an amount equivalent to six (6) months of Mr. Murray's annual salary if he is terminated by City Council at any time provided City shall not be liable for any severance pay if he is terminated for reasons of malfeasance in office or conviction of a crime involving moral turpitude.

h. Other Benefits:

City Manager shall be eligible for all other City benefits which are authorized for all other City employees and not otherwise limited by law.

i. Automobile:

City Manager shall be provided with the use of a City vehicle or an in lieu monthly transportation allowance pursuant to the provisions of Resolution No. R-250946.
