
WHEREAS, the Planning Commission of The City of San Diego held a public hearing on May 30, 1985 to consider the proposed amendment of the UPTOWN COMMUNITY PLAN; and

WHEREAS, the proposed amendment affects that portion of Uptown located on Second Avenue, between Palm Street to the south and Thorn Street to the north, by redesignating the community plan's land use from medium-high density, 45-74 dwelling units per net residential acre (du/nra), to low density, 5-9 dwelling units per net residential acre (du/nra); and

WHEREAS, the Council of The City of San Diego has reviewed the proposed amendment of the UPTOWN COMMUNITY PLAN and approves and recommends adoption of the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the amendment of the UPTOWN COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. ^{RR-}263776, be, and the same is hereby approved and adopted.
