CONSTRUCTION OF SKYVIEW NEIGHBORHOOD PARK, San Diego, California

filed in the office of the City Clerk of the City of San Diego, California, on AUG 5 1985 and bearing official Document No. W.O. 118375 be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF SKYVIEW NEIGHBORHOOD PARK.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$68,500 from Park Service District Funds (\$6,701 from PSD Fund 11690; \$11,318 from PSD Fund 11691; \$5,776 from PSD Fund 11692; \$11,475 from PSD Fund 11693; \$33,230 from PSD Fund 15682) to CIP No. 29-409 SKYVIEW NEIGHBORHOOD PARK - DEVELOPMENT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$324,600 from CIP No. 29-409 SKYVIEW NEIGHBORHOOD PARK - DEVELOPMENT is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
