WHEREAS, on July 8, 1985, the Rules Committee reviewed IRD Report No. 85-79 concerning AB 1134 (M. Waters), H.R. 1460 (Gray), and S. 635 (Kennedy); and


WHEREAS, the Rules Committee voted 5-0 to support said bills and forward said matter to the full Council for appropriate action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby supports AB 1134 (M. Waters), which would require the divestment by various State pension funds of investments in companies or banks doing business in South Africa or with the South African government.

BE IT FURTHER RESOLVED, that this Council hereby further supports H.R. 1460 (Gray) and S. 635 (Kennedy), which would bar United States corporations from making new investments or loans in South Africa, and which would outlaw the importation of South African gold coins into the United States and the export to the South African government of United States computer products or nuclear technology.
