

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO MODIFYING LANGUAGE OF THE FIRST AMENDMENT TO GRANT AGREEMENT WITH THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR AN URBAN DEVELOPMENT ACTION GRANT FOR THE RECONSTRUCTION OF THE HORTON GRAND AND GRAND SADDLERY HOTELS.
