Vauclain Point Status Report

## SUMMARY

<u>Issue</u> - Shall the City formally notify the County of its intent to negotiate in good faith for the acquisition of Vauclain Point?

<u>Manager's Recommendation</u> - Transmit such a notice to the County of San Diego.

Other Recommendations - None.

Fiscal Impact - It is anticipated that the cost of acquiring Vauclain Point will be borne by the San Diego Hospice Corporation.

## **BACKGROUND**

This is a status report on the Vauclain Point acquisition.

Vauclain Point is a 12-acre parcel which is owned by the County of San Diego. The site contains approximately 6.5 usable acres. It is on the mesa above the south side of Mission Valley at the end of Third Avenue.

The County is interested in disposing of the property, and since it is within the jurisdiction of the City of San Diego, state law requires that the City first be offered an opportunity to acquire the site. In April, the County formally offered to sell Vauclain Point to the City for park and recreation or open space purposes.

ついりて1 -**0092**2 The City Manager recommended that the property not be acquired for those purposes. However, at the same time, City staff was attempting to find a location for the San Diego Hospice Corporation, and the site was thought to be exceptionally well-suited for Hospice use. Subsequently, a task force was established which consisted of Councilman Bill Cleator, Supervisor Leon Williams, Dr. Doris Howell (San Diego Hospice), Ms. Joy Higginbotham (Vice President of the Vauclain Point Advisory Committee), and representatives of the City and County staffs.

The City was initially given until May 10th to decide whether or not it wanted the property. Various extensions have been granted and most recently, on July 9th, the Board of Supervisors extended the City's deadline until September 10, 1985. Meanwhile, discussions have been held with the San Diego Hospice Corporation and with the County staff. The Hospice Corporation has substantiated that it has a donor that is willing to fund the acquisition of the property so long as the price is considered fair and reasonable. To this end, the Hospice Corporation has just received an independent appraiser's valuation of the property. The appraisal of Hospice is now being evaluated by County and City staffs. The City's Park and Recreation Department and Hospice representatives are also discussing the open space and park development criteria which would be applied to the site.

When the Board of Supervisors acted to extend the City's deadline on July 10th, it also directed the County staff to negotiate a sale to the City upon receipt of a formal notice from the City of their intent to acquire the property. Since previous action relative to Vauclain Point has been by the PF&R Committee and not by the full Council, it is, therefore, recommended that such a notice be transmitted to the Board of Supervisors.
