

That the expenditure, not to exceed \$119,150 (\$114,400 from CIP No. 29-462 ADAMS FIELD HOUSE REPLACEMENT and \$4,750 from CIP No. 58-007 ANNUAL ALLOCATION - OVERHEAD & OTHER CITY COSTS FOR FEDERAL GRANTS, Revenue Sharing Fund 18013) to supplement funds previously authorized by Resolution No. 263276 adopted on May 28, 1985 is hereby authorized solely and exclusively for providing funds for said project and related costs.
