BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$332,900 by FRANK STAHL CONSTRUCTION for CONSTRUCTION OF ADAMS FIELD HOUSE REPLACEMENT in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the specifications on file in the Office of the City Clerk as Document No. 118396.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$114,400 from Mid-City Park Fees Fund 39094 to CIP No. 29-462 ADAMS FIELD HOUSE REPLACEMENT.
3. That the expenditure, not to exceed \$119,150 (\$114,400 from CIP No. 29-462 ADAMS FIELD HOUSE REPLACEMENT and \$4,750 from CIP No. 58-007 ANNUAL ALLOCATION - OVERHEAD & OTHER CITY COSTS FOR FEDERAL GRANTS, Revenue Sharing Fund 18013) to supplement funds previously authorized by Resolution No. 263276 adopted on May 28, 1985 is hereby authorized solely and exclusively for providing funds for said project and related costs.
