

RESOLUTION No. R- 263828 (R-86-69)

Adopted on AUG 12 1985

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. INDUSTRIES SUPPLY CO., 2. SAN DIEGO PIPE & SUPPLY CO., 3. LIBERTY EQUIPMENT & SUPPLY CO. and 4. FAMILIAN PIPE & SUPPLY are hereby accepted and the City Manager is hereby authorized to execute contracts for PIPE, FITTINGS AND MISCELLANEOUS PLUMBING SUPPLIES as may be required for the period of one (1) year beginning September 1, 1985 through August 31, 1986 per prices on file in the Purchasing Department as follows:

1. INDUSTRIES SUPPLY CO. - Section I, Section II, Section V, Items 1-9, 14, 16 and 18, all sections with price escalation not to exceed 3% of bid prices for the contract year; terms 2% 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period, price escalation not to exceed 10% of prices in effect at end of the initial contract year.
2. SAN DIEGO PIPE & SUPPLY CO. - Section III and Section V, Items 9-12, 15, 17, 19-23; terms 2% 10 days, plus sales tax, with an option to renew contract for an additional one (1) year period, price escalation not to exceed 6% of prices in effect at end of the initial contract year.
3. LIBERTY EQUIPMENT & SUPPLY CO. - Section IV, with price escalation not to exceed 5% of bid prices during the contract period; terms 2% 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period with price escalation not to exceed 8% of prices in effect at end of the initial contract year.
4. FAMILIAN PIPE & SUPPLY - Section V, Item 13, price escalation not to exceed 10% of bid price for the contract year; terms 2% 10 days, with an option to renew contract for an additional one (1) year period.
