RESOLUTION NUMBER R- 263835

ADOPTED ON AUG 12 1985

WHEREAS, the City Council adopted Resolution No. R-262081 on December 3, 1984 designating those Councilmembers who are to serve as representatives and liaison and alternates to various specified organizations for the period ending December 1, 1985; and

WHEREAS, Item 16 of said resolution designated Councilmembers Dick Murphy and Uvaldo Martinez as representatives to the San Diego Energy Recovery Project (SANDER); and

WHEREAS, Councilmember Dick Murphy has since been appointed as a judge of the Municipal Court, creating thereby a vacancy in representation to SANDER; and

WHEREAS, the City Council now wishes to fill the vacancy until such time as a replacement Councilmember is elected to District 7; and

WHEREAS, the Council further desires to add to such designation for SANDER one (1) alternate appointment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Resolution No. R-262081, adopted December 3, 1984, be and the same is hereby amended by amending the appointments as council representative and adding an alternate to Item 16 thereon, entitled SAN DIEGO ENERGY RECOVERY PROJECT (SANDER) to read as follows:

16. SAN DIEGO ENERGY RECOVERY PROJECT (SANDER)

Bill Cleator - representative


Uvaldo Martinez - representative
