WHEREAS, the operating agreement between the City and the San Diego Data Processing Corporation requires that an annual budget be submitted to and approved by the City Council; and


WHEREAS, the Corporation has submitted a budget for FY 1986 totaling \$12,312,252; and

WHEREAS, of this amount \$10,348,152 reflects expenditures for services to City departments which were reviewed as part of the annual budget process and funded in department appropriations and the remaining amount of \$1,964,100 primarily reflects Automated Regional Justice Information System (ARJIS) costs to be recovered from other participating cities, the City/County Library Circulation System, and the County's contribution to the Regional Urban Information System; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to Section 3(a) of the Operating Agreement between The City of San Diego and the San Diego Data Processing Corporation, the Council has reviewed and hereby approves the proposed FY 1986 budget for said Corporation, a copy of which is on file in the office of the City Clerk as Document No. RR- 263845.
