


RESOLUTION NUMBER R- 263851

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to appear before the Port District Board to request that plans and specifications for the San Diego Convention Center be revised to provide for gas air conditioning provided it does not delay construction of the Convention Center and the City's Representatives on the Board are requested to vote in favor of said revision under those conditions.

BE IT FURTHER RESOLVED, that if approved by the Port District, the expenditure of an amount not to exceed \$820,000 from the TOT New Convention Facility Fund (10225) Contingency Reserve, is hereby authorized, solely and exclusively for the purpose of providing funds for the above revision.
