

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$306,975 from CIP 37-137.0 Revenue Sharing Fund 18013 for the purpose of executing this contract and related costs is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
