That the expenditure, not to exceed \$239,585 (\$54,585 from funds previously allocated by Resolution No. R-263679 adopted on July 15, 1985, and the aforementioned \$185,000 in grant funds hereby allocated) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess funds, if any, to the appropriate reserves.
