APPROVING MAP OF THE HEIGHTS BY ROBINHOOD.

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Samuel F. Safino, RCE, entitled "THE HEIGHTS BY ROBINHOOD being a subdivision of a portion of Section 22, Township 18 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to official plat thereof," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Cagayan Avenue, Mindanao Way, Lanao Lane, Binday Way, Subol Court, Agno Court, Lungos Court, and a portion of Beyer Boulevard, and said streets and portion of a street are hereby declared to be public streets and portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Palm Avenue, adjacent and contiguous to Lot 1, and Lots 26 through 41, inclusive, in and to Beyer Boulevard, adjacent and contiguous to Lots 41 through 45, inclusive, Lots 66 and 67, Lots 90 through 92, inclusive, and Lots 106 through 109, inclusive, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for open space over, upon and across portions of Lots 107 through 126, inclusive, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of a public street are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities and the open space easements, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
