APPROVING MAP OF VIEW RIDGE - UNIT NO. 2.

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by W. R. Nothomb, L.S., entitled "VIEW RIDGE - UNIT NO. 2, being a subdivision of a portion of Quarter Section Lot 52 of Rancho de la Nacion, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 166 by Morrill, filed in the office of the County Recorder of San Diego County, together with a portion of Parcel 1 of Parcel Map No. 11919, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, together with portions of Ledgewood Place and Ridgecrest Drive as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Bullock Drive and Deep Dell Road and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over Lot 114 as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities and the open space easement as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
