RESOLUTION NUMBER R- 263924

ADOPTED ON AUG 19 1985

WHEREAS, members of the City Council of San Diego, the City Attorney and the City Manager are frequently required to travel within the greater metropolitan area of the City of San Diego in order to attend meetings and perform other duties in the discharge of their offices; and

WHEREAS, the only convenient and expeditious means of transportation available to these officials are either their personal automobile or automobiles placed at their disposal by the City; and

WHEREAS, it has long been and continues to be the policy of the City that each member of the Council, the City Attorney and the City Manager shall have at their disposal automobiles in which to travel incident to the discharge of their duties; and

WHEREAS, it is now desired to use a more standardized calculation bases upon national statistical studies; and

WHEREAS, such calculations of national average costs are now being conducted by Runzheimer and Company, transportation consultants, for the American Automobile Association; and

WHEREAS, those calculations are adaptable and applicable to the City of San Diego program of reimbursement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that commencing January 1, 1980, the monthly automobile reimbursement for members of the City Council, the City Attorney and the City


Manager, for expenses necessarily incurred in the operation of their personal automobiles in the performance of their duties, shall be based on the national average costs of operating an automobile as computed by Runzheimer and Company, transportation consultants, for the American Automobile Association.

BE IT FURTHER RESOLVED, that any of the above named officials electing to utilize a City-owned or leased automobile in the performance of their duties shall be reimbursed upon submission of paid invoices or other documents for actual costs of gasoline and oil and other normal minor expenses incurred.

BE IT FURTHER RESOLVED, that Resolution No R-250946, passed and adopted on January 7, 1980, be and it is hereby rescinded.
