

RESOLUTION No. R-263947 (R-86-270)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of GPS INDUSTRIES is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SODIUM HYPOCHLORITE 12.5% IN SOLUTION as may be required for a period of one (1) year beginning October 1, 1985 through September 30, 1986, at a cost per gallon of \$0.525, for a total estimated cost of \$52,500.00; terms net 30 days, plus sales tax; with an option to renew contract for an additional one (1) year period with a price escalation not to exceed 20% of bid price.
2. That the Purchasing Agent is hereby authorized to purchase sodium hypochlorite on an emergency basis in the event the contractor fails to deliver this material on any occasion from Jones Chemical or Imperial West Chemical, per prices on file in the Purchasing Department, or on the open market, in the event the emergency vendors are unable to deliver.
