BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of HILL BROS. CHEMICAL CO. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of FERRIC CHLORIDE IN 55 GALLON DRUMS as may be required for a period of six (6) months beginning November 1, 1985 through April 30, 1986 at a cost of \$1.10 per gallon for a total estimated cost of \$10,890.00; terms net 30 days, plus sales tax, plus refundable drum deposits of \$30.00 each; with an option to renew contract on a month-to-month basis for up to twelve (12) additional months with a price escalation not to exceed 15% of bid price.
