

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF ROSE AND TECOLOTE CREEK STORM DRAIN INTERCEPTOR, PHASE III, San Diego California filed in the office of the City Clerk of the City of San Diego, California, on SEP 9 1985 and bearing official Document No. W.O./64063 be, and the same are hereby approved.
- 2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF ROSE AND TECOLOTE CREEK STORM DRAIN INTERCEPTOR, PHASE III.
- 4. That the expenditure, not to exceed \$242,000 from Transient Occupancy Tax Fund 60213 CIP No. 22-050.3 MISSION BAY STORM DRAIN INTERCEPTOR SYSTEM PHASE III is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
