- 5. That the City Auditor and Comptroller is hereby authorized to transfer \$48,000 from Capital Outlay Fund 30245, CIP No. 68-001 ANNUAL ALLOCATION COOPERATIVE SIGNAL PROJECTS to CIP No. 62-260 NORTH HARBOR DRIVE AND RYAN MAIN GATE.
- 6. That the expenditure, not to exceed \$123,000 (\$48,000 from Captial Outlay Fund 30245 and \$65,000 from Revenue Sharing Fund 18013, CIP No. 62-260 NORTH HARBOR DRIVE AND RYAN MAIN GATE; and \$10,000 from Trust Fund 63021 of the City of San Diego) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
