

RESOLUTION No. R 263962 (R-86-331)

Adopted on SEP 9 1985

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNALS AND STREET LIGHTING SYSTEMS AT GILMAN DRIVE AND VIA ALICANTE, AND AT GOVERNOR DRIVE AND RADCLIFFE DRIVE, San Diego California filed in the office of the City Clerk of the City of San Diego, California, on SEP 9 1985 and bearing official Document No. U.O. 118533 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNALS AND STREET LIGHTING SYSTEMS AT GILMAN DRIVE AND VIA ALICANTE, AND AT GOVERNOR DRIVE AND RADCLIFFE DRIVE.
4. That the City Auditor and Comptroller is hereby authorized to consolidate CIP No. 62-253 GOVERNOR DRIVE AND RADCLIFFE DRIVE into CIP No. 62-259 GILMAN DRIVE AND VIA ALICANTE.
5. That the City Auditor and Comptroller is hereby authorized to transfer \$81,150 from Revenue Sharing Fund 18013 CIP No. 62-253 GOVERNOR DRIVE AND RADCLIFFE DRIVE to CIP No. 62-259 GILMAN DRIVE AND VIA ALICANTE.
6. That the expenditure, not to exceed \$158,300 from Revenue Sharing Fund 18013 CIP No. 62-259 GILMAN DRIVE AND VIA ALICANTE is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
