- 4. That the agreement executed with the State of California to include Supplement No. 44 to Local Agency State Agreement No. 11-5004 HES-000S(187) is hereby approved.
- 5. That the City Auditor and Comptroller is hereby authorized to transfer \$65,000 from Capital Outlay Reserve Fund 90245 and \$70,000 from Revenue Sharing Fund 91-801.3 to CIP No. 61-001 ANNUAL ALLOCATION SIGNAL INSTALLATIONS TO ACCOMMODATE SUDDEN TRAFFIC CHANGES.
- 6. That the expenditure, not to exceed \$135,000 from CIP No. 61-001 ANNUAL ALLOCATION SIGNAL INSTALLATIONS TO ACCOMMODATE SUDDEN TRAFFIC CHANGES (\$65,000 from Capital Outlay Fund 30245 and \$70,000 from Revenue Sharing Fund 18013) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
