

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF WABASH NEIGHBORHOOD PARK IRRIGATION IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$35,000.00 from CIP No. 29-471 WABASH NEIGHBORHOOD PARK - IRRIGATION SYSTEM (\$24,000.00 from Community Development Block Grant Fund 18520 and \$11,000.00 from Park Service District Fund 15630) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
