BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

INSTALLATION OF CITY OPERATIONS BUILDING FIFTH FLOOR PARTITIONS

AND CARPET.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$95,000 from the Water Revenue Fund 41502, Unallocated Reserve 70679 to the Water Operating Fund 41500, Administrative Services Program 70611.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$95,000 from Water Operating Fund 41500 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
