WHEREAS, the assessment is based upon categories of benefit for those businesses located within the Business Improvement District; and

WHEREAS, the City contracted with the Hillcrest Association when the District was established to accomplish the major objectives of the District and the Hillcrest Association has met the requirements of their first year agreement; and

WHEREAS, it is recommended that this agreement be renewed for the period between July 1, 1985 to June 30, 1986; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an agreement with the Hillcrest Business Improvement Association, Incorporated, a nonprofit California corporation, for the purpose of performing the requirements of the Hillcrest Business Improvement District for the period July 1, 1985 through June 30, 1986 as set forth in and pursuant to the terms and conditions of the agreement on file in the office of the City Clerk as Document No. RR- 263994
