WHEREAS, on August 5, 1985, the Regional Employment and Training Consortium Policy Board approved an additional allocation of \$40,000 in JTPA funds to augment the REGY Summer Youth contract; and


WHEREAS, the total funding level for this program has been increased from \$1,760,000 to \$1,800,000 and

WHEREAS, this modification formalizes REGY's role in implementation of the Summer Training and Employment Program (STEP) which is utilizing a Ford Foundation grant through Public Private Ventures, Inc. whereby REGY and the San Diego Unified School District combine basic skills remediation and work experience training for 300 fourteen and fifteen year old JTPA eligible youth; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to modify the existing REGY Summer Youth Contract by accepting \$40,000 in additional JTPA funds.
