
BE IT RESOLVED, by the Council of The City of San Diego as follows:

CANON c/o REMCO BUSINESS PRODUCTS are hereby accepted and the City Manager is hereby authorized to execute contracts for the RENTAL OF COPIERS AND DUPLICATORS and copier supplies as may be required for a period beginning September 1, 1985, or date of installation, whichever is later, through June 30, 1988, per prices on file in the Purchasing Department, with an option to rent additional equipment of the same model, at the same rate, as follows:
