WHEREAS, Mr. Sylvester Murray was hired by the City Council as City Manager effective September 9, 1985 pursuant to Resolution No R-263769, dated July 29, 1985; and

WHEREAS, Mr. Murray's compensation and terms and conditions of employment were set forth in said resolution as Attachment A thereto; and

WHEREAS, it has since been determined that certain benefits normally available were inadvertently overlooked in the content of Attachment A; and

WHEREAS, it is now desired to take appropriate action in respect to the City Manager's terms and conditions of employment to provide the benefits inadvertently omitted; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Attachment A to Resolution No. R-263769, be and the same is hereby amended to add section "j" to read as follows:

j. Management Benefits: City shall pay an annualized amount of \$5,282 as Management Benefits, commencing September 9, 1985 through June 30, 1986. The annualized amount shall be subject to readjustment effective July 1, 1986.

BE IT FURTHER RESOLVED, that the requirement to serve twelve (12) consecutive months of eligible employment from date of hire in order to participate in the City of San Diego Employees' Long

Term Disability Income Plan, a copy of which is on file in the office of the City Clerk as Document No. RR- 254623, be and the same is hereby waived for Mr. Murray, effective September 9, 1985.
