WHEREAS, in recent years, nearly 3,000 motor vehicle occupants are killed and over 240,000 are injured in traffic accidents in California each year; and

WHEREAS, traffic accidents are the leading cause of death among people age 44 years and younger; and

WHEREAS, vehicle seat belts, when worn properly, reduce the chances of sustaining a moderate to critical injury in a traffic accident by fifty percent; and

WHEREAS, seat belts cut fatalities by forty-five percent; and WHEREAS, more than half of all injury-producing accidents involve speeds lower than 45 miles per hour; and

WHEREAS, three out of four accidents happen within twenty-five miles of home; and

WHEREAS, seat belts help the driver maintain vehicle control in emergency situations; and

WHEREAS, in almost any collision, a person is better off being held inside the car by a safety belt because it helps avoid serious injury; and

WHEREAS, one out of five serious injuries to passengers is caused by nonbelted occupants being thrown into each other; and

WHEREAS, the seat belt is now designed to allow riders to move freely in their cars and is also designed to automatically lock in place should the car come to a sudden halt; and


WHEREAS, nearly all passenger cars on the road today contain seat belts, yet less than twenty percent of all Americans use this life-saving device; and

WHEREAS, it is the intention of the City to sponsor and present, in conjunction with the Automobile Club and San Diego Safety Council, a public display on the importance of seat belts, at noon on September 10, 1985 in the Community Concourse area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that September 1985 be declared "Seat Belts to Work Month" in The City of San Diego and that everyone is reminded to buckle up to save lives and prevent injuries.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to participate with the Automobile Club and the San Diego Safety Council in providing a public display which shows the importance of seat belts, said event to take place in the Community Concourse area at Noon on September 10, 1985.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to transfer the sum of \$200 from the General Fund 100, Unallocated Reserve (605) to the Convention and
