
RESOLUTION NUMBER R- 264044

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Settlement Agreement, a Mutual Release of Claims, a Sewer Capacity Agreement and a Will-Serve Agreement which will settle litigation between NCR, AVCO and the City for \$479,780 to acquire 282,500 gallons per day of sewage capacity in the Rancho Bernardo Sewer System which connects with Escondido, under the terms and conditions set forth in the said Agreements on file in the office of the City Clerk as Document Nos. RR-264044-1, RR-264044-2, RR-264044-3 and RR-264044-4.
