- 3. That the City Manager is hereby authorized to transfer \$8,000 from CDBG Fund 18520 to CIP No. 29-442 ENCANTO COMMUNITY PARK IMPROVEMENTS.

That the expenditure, not to exceed \$698,601 from CIP No. 29-442 ENCANTO COMMUNITY PARK IMPROVEMENTS (\$242,000 from CDBG Fund 185191, \$43,000 from CDBG Fund 18519, \$88,000 from CDBG Fund 18520, \$120,000 from Capital Outlay Fund 30245 and \$205,601 from PSD Funds) is hereby authorized solely and exclusively for providing funds for said project and related costs.
