
RESOLUTION NUMBER R- 264065

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$36,995 from CDBG Fund 18521, Department 5833, Organization 3312, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
