WHEREAS, the employment of a private analytical laboratory which is immediately available is essential for accomplishment of the prompt initial analysis of surface and ground water; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City's closure and site maintenance plan and program, as described in City Manager Report No. 85-435 of September 11, , 1985, and on file in the office of the City Clerk as Document No. RR-264()68; is hereby approved for implementation.

BE IT FURTHER RESOLVED, that City Council Policy No. 300-7 is hereby waived to enable the immediate employment of S-Cubed, inc. for analysis services.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute for and on behalf of the City an agreement with S-Cubed, Inc. for professional services to accomplish sampling, testing and analysis of surface and ground water. A copy of said agreement is on file in the office of the City Clerk as Document No. RR-264068-2-

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$30,840.00 of Capital Outlay Funds from CIP Project 37-250, sole and exclusively the professional services and related costs is hereby authorized.
