BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Change Order in the City's construction contract with Metro-Young Construction Company for Eastgate Technology Park Unit No. 1, by adding \$120,000 (for a total contract price of \$5,257,165.25) for the purpose of providing funds for the excavation and compaction of large amounts of alluvium and subsurface soil in connection with the widening of Eastgate Mall, a form of which Change Order is on file in the office of the City Clerk as Document No. RR- 264069

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$120,000 from the project contingency reserve available in the Industrial Development Fund 30248, CIP 39-040, Pueblo Lands Development, for the Change Order is hereby authorized and approved.

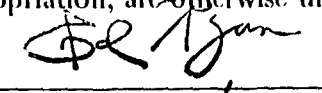

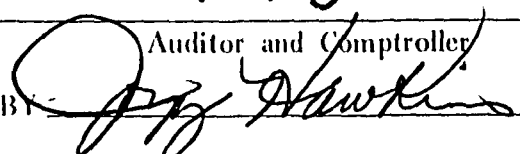
