

RESOLUTION NUMBER R- 264072

ADOPTED ON SEP 16 1985

WHEREAS, the Council of The City of San Diego held a public hearing on August 20, 1985 to consider a request for a Threshold Determination based on Council Policy No. 600-30D on a proposed amendment to the Phased Development Areas Map of the PROGRESS GUIDE AND GENERAL PLAN for The City of San Diego for the purpose of shifting those properties known as GENSTAR-SORRENTO HILLS from Future Urbanizing to Planned Urbanizing; and


WHEREAS, the Request for a Threshold Determination conforms to Council Policy 600-30 (General Plan Amendments to Shift Land from Future Urbanizing to Planned Urbanizing Area), Section D, based on the analysis contained within Planning Report No. 85-426; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Request for Threshold Determination is approved based on the finding that there is a reasonable basis for a substantive review of the requested amendment, without prejudice to the Council's ability to grant or deny said amendment upon final substantive review and the finding that the proposed amendment may provide the City with substantial and unique public benefits.

BE IT FURTHER RESOLVED, that this matter shall be submitted to the voters for consideration in the event that Proposition A is approved by the voters.

BE IT FURTHER RESOLVED, that the amendment shall be referred to the Planning Commission for substantive review pursuant to the provisions of Council Policy 600-30.
