RESOLUTION NUMBER R- 264090

ADOPTED ON SEP 23 1985

WHEREAS, the City Council of San Diego is vitally concerned with the problem of aircraft noise in the neighborhoods surrounding San Diego International Airport (Lindbergh Field); and

WHEREAS, the City Council of San Diego recognizes that controlling noise at its source is the most effective method of noise abatement; and

WHEREAS, the City Council of San Diego also recognizes the tremendous financial burden placed upon the airline industry to operate new generation, Part 36, State III aircraft, which are the quietest commercial aircraft available; and

WHEREAS, Pacific Southwest Airlines has historically been a leader in the airline industry in working to reduce aircraft noise; and

WHEREAS, Pacific Southwest Airlines has spent more than \$1 billion during the past five years to operate a Stage III fleet of aircraft, making it the first major airline at San Diego International Airport (Lindbergh Field) to use all Stage III aircraft; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, this Council commends Pacific Southwest Airlines for its commitment to the residents of San Diego in reducing noise in the environs of

San Diego International Airport (Lindbergh Field), thus
continuing its historical leadership role in noise abatement.
