

RESOLUTION No. R- 264092 (R- 86-404)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of IMPERIAL WEST CHEMICAL COMPANY is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of FERRIC CHLORIDE as may be required for a period of one (1) year beginning November 1, 1985 through October 31, 1986, at a delivered price of \$0.08135 per lb. for a total estimated cost of \$772,825.00; terms net 30 days, plus sales tax; with an option to renew contract for an additional one (1) year period with a price escalation not to exceed 15% of bid price.
2. That the Purchasing Agent is hereby authorized, in the event the contract vendor fails at any time during the contract period to deliver material meeting specifications, to obtain FERRIC CHLORIDE from CHEMWEST INDUSTRIES, INC. under the terms of the emergency price clause in the specifications, at a cost of \$0.1125 per lb. dry weight for material and \$0.97 per cwt. total weight basis for freight; terms net 30 days, plus applicable sales tax.
