- 1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF AND STREET LIGHT SYSTEMS AT INDIA STREET AND SIGNAL SASSAFRAS AND AT 45TH STREET AND MARKET STREET, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on SEP 23 1985 and bearing official Document No. W.O. 1224/4 be. and the same are hereby approved.
- That the Purchasing Agent of the City of San Diego be, 2. he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHT SYSTEMS AT INDIA STREET AND SASSAFRAS AND AT 45TH STREET AND MARKET STREET.
- 4. That the City Auditor and Comptroller is hereby authorized to consolidate CIP No. 62-256 MARKET STREET AND 45TH STREET into CIP No. 62-255 INDIA STREET AND SASSAFRAS STREET.
- 5. That the City Auditor and Comptroller is hereby authorized to transfer \$83,150 from Revenue Sharing Fund 18013 CIP No. 62-256 MARKET STREET AND 45TH STREET to CIP No. 62-255 INDIA STREET AND SASSAFRAS STREET.
- 6. That the expenditure, not to exceed \$141,800 from CIP No. 62-255 INDIA STREET AND SASSAFRAS STREET (\$83,150 from Revenue Sharing Fund 18013 and \$58,650 from Gas Tax Fund is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
