- That the expenditure, not to exceed \$439,500 from CIP No. 4. 62-006.1 CLAIREMONT MESA BOULEVARD MASTER TRAFFIC SIGNAL SYSTEM - EXTENSION (\$432,000 from Gas Tax Fund 30219 \$7,500 from Capital Outlay Fund 30245) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
- 5. That the City Auditor and Comptroller is authorized to pay to the State of California a sum not to exceed \$1,000 from the expenditure hereby authorized for the purpose of reimbursing CALTRANS for inspection services rendered during the course of the contract.
